CAP REGULATION 130-2

Aircraft Maintenance

CIVIL AIR PATROL AIRCRAFT MAINTENANCE MANAGEMENT

CAPR 130-2, dated 6 October 2023, is supplemented as follows:

{5.6.1 Added.} Wing/cowling covers will be used on non-hangered aircraft to prevent icing on horizontal surfacing when conditions exist.

{5.6.1.1 Added.} Covers are tail specific and need to be moved with the aircraft when being relocated to another unit or for maintenance.

{5.6.2 Added.} Plug-in engine block/oil pan heaters will be used 30 minutes prior to engine start when outside air temperature is below 40 degrees F and hangar use is not feasible.

{5.6.1.1 Added.} Forced air warming may also be used for criteria listed in 5.6.2

{10.4.5.1 Added.} Aircraft within 25 miles of a body of salt water will be checked annually for corrosion, and preventative treatment will be applied as needed.

{14.5.1 Added.} Survival gear will be carried as appropriate in accordance with Alaska Statute AS 02.35.110 (Attachment 2).

{14.5.1.1 Added.} Aircrews will be responsible for equipping sleeping bags and snowshoes.

{16.1 Added.} List of approved maintenance personnel and facilities performing maintenance are listed in Attachment 3. The Wing AMO will maintain a list with copies of their liability insurance.

ATTACHMENT 2
AS 02.35.110

[Alaska Statute 02.35.110i Emergency Rations & Equipment](#) requires that an airman may not make a flight inside the state with an aircraft unless emergency equipment is carried as follows:

1. The minimum equipment during the summer months is as follows: food for each occupant for one week; one axe or hatchet; one first aid kit; an assortment of fishing tackle such as hooks, flies, and sinkers; one knife; fire starter; one mosquito head net for each occupant; and two signaling devices such as colored smoke bombs, pistol shells, etc. sealed in metal containers.
2. In addition to the above, the following must be carried as minimum equipment from October 15 to April 1 of each year: one pair of snowshoes; one sleeping bag; one wool blanket for each occupant over four.
